## Project 150 Raffle Terms and Conditions

**1. Introduction** By entering the Project 150 Raffle, participants agree to be bound by these terms and conditions. The organiser of this raffle is Hallfield School Trust, hereinafter referred to as "Organiser." Hallfield School Trust is a company limited by guarantee, registered in England No. 631045. Registered Office: Hallfield School Trust, 48 Church Road, Edgbaston, Birmingham B15 3SJ. Registered Charity No. 528956.

## 2. Eligibility

- Participants must be aged 18 years or over.
- The raffle is open to residents of the United Kingdom.
- Employees of the Organiser, their family members, and anyone else connected in any way with the organisation or judging of the raffle are not eligible to participate.

## 3. Entry Period

- The raffle begins on Friday 20 September 2024, 12:00 GMT and ends on Friday 6 December 2024, 12:00 GMT, hereinafter referred to as the "Entry Period."
- Entries received outside the Entry Period will not be considered.

## 4. How to Enter

- Participants can enter the raffle by purchasing a ticket via the Hallfield School website: <https://www.hallfieldschool.co.uk/raffle/> or dedicated Project 150 Raffle Stripe page <https://donate.stripe.com/bLY7w98nZ4GVe3ufZ0>.
- Each participant is allowed to purchase an unlimited number of entries into the raffle.

## 5. Entry Fee

- The entry fee for the raffle is £150 per entry.
- All entry fees are non-refundable.

## 6. Prizes

- The prize for the raffle is one terms' fees for one child, redeemable only against the Spring 2025 Term Fees.
- The winner is allowed to elect which child at Hallfield School they would like the raffle prize to be redeemed against.
- Prizes are non-transferable and no cash or other alternatives will be offered.

- The prize cannot be used for fees in lieu of notice.
- For children who hold a bursary, scholarship or sibling discount – the amount will be redeemable against the portion that is normally chargeable to the pupil’s family in their usual termly invoice, after the discount has been applied.
- For children who are in receipt of nursery funding - the amount will be redeemable against the proportion which is normally chargeable to the pupil’s family in their termly invoice after the funding has been applied
- For those children who are not on a term time fee basis - the amount will be redeemable against the equivalent of 12 weeks of normally chargeable fees to the pupil’s family after the application of any funding that would normally be applied.
- For those pupils in a Fees in Advance scheme – the amount will be credited to your scheme and repaid at the end of your scheme’s term.
- The prize amount only covers the fees and no extras such as school trips, music lessons, chargeable clubs, uniform etc.

## **7. Winner Selection and Notification**

- All entrants will be entered into a winner selector tool, namely Wheel of Names software <https://wheelofnames.com/>. The winner will be selected at random by <https://wheelofnames.com/>
- The draw will be video recorded in accordance with the [Code of Fundraising Practice](#) but not shared for the data protection of ticket holders.
- The draw will take place on Tuesday 10 December 2024, 11:00 GMT and will be witnessed by three members of the Senior Leadership Team and recorded by the marketing department.
- The recording will be kept on file but not shared publicly.
- All entrants will be entered into the prize draw. For people with multiple tickets their name will be entered into the prize draw, in accordance with the number of tickets they purchased.
- The winner will be notified by phone and email within 7 days of the draw date.
- If we are unable to contact a prize-winner, and a prize remains unclaimed for six months following our first attempt to notify the prize-winner, we may apply the prize as we see fit, including re-offering the prize in future raffles.
- If, for any reason, the draw date needs to be delayed from that shown on the ticket, the Organiser will take all reasonable steps to make sure that everyone who has bought a ticket knows about the change, and will discuss it with the issuer of the licence.

## **8. Publicity**

- The Organiser will not make details of winners public without their permission.
- By entering this raffle, participants agree to the use of their name, likeness, and entry for promotional purposes without additional compensation unless prohibited by law.

## **9. Limitation of Liability**

- By entering, participants agree to release and hold harmless the Organiser, its affiliates, advertising and promotional agencies, and their respective directors, officers, employees, and agents from any and all liability for any injuries, loss, or damage of any kind arising from or in connection with the raffle or receipt or use of any prize.

## **10. Privacy and data protection**

- You consent to any personal information you provide in entering the prize draw being used by Hallfield School for the purposes of administering the prize draw, and for those purposes as defined within our privacy notice.
